The program is based on a first come first serve basis with limited funds. Labor will be the responsibility of the business. If approved, the business must provide the UEA with a signed contract from the painter. All painting must be completed by October 31st.

Applicants may reapply and receive assistance every five years. Subject to revaluation.
